



Event Policies, Terms & Conditions

By registering for an event, you agree to the following NAMA registration policies, terms and conditions:

CANCELLATION POLICY

Only written cancellation requests submitted via email to events@namanow.org and received by Friday, March 1, 2024, will receive a refund, less a \$100 administrative fee. No refunds will be granted after March 1, 2024, and no refunds will be given for no-shows. If registering at the member rate and your membership is lapsed at event date, you must renew your membership or pay the difference between the member and non-member registration fee to receive your badge.

SUBSTITUTIONS

Attendee substitutions may be made at any time prior to the start of the event, provided that the substitute is from the same organization.

PHOTO POLICY

NAMA reserves the right to use any photograph or video taken at any event sponsored by NAMA, without the expressed written permission of those included within the photograph or video. NAMA may use the photograph or video in publications or other media material produced, used or contracted by NAMA including but not limited to: brochures, invitations, books, newspapers, magazines, television, websites, etc. By attending the event, you waive and release any claims you may have related to the use of recorded media of you at the event, including, without limitation, any right to inspect or approve the photo, video or audio recording of you, any claims for invasion of privacy, violation of the right of publicity, defamation, and copyright infringement or for any fees for use of such recorded media.

CHILDREN

No one under age 16 will be admitted to the Expo Hall. Only nursing infants (swaddled or carried) are allowed on the show floor. No car seats, buggies, wagons or strollers will be permitted.

CAMERAS AND RECORDING DEVICES

Cameras and recording devices are not allowed on the trade show floor or in the education sessions.

BADGE POLICY

An event badge will be provided to all attendees upon check-in and must be worn at all times during the event. A badge reprint fee of \$50.00 will be charged for misplaced or lost badges. Attendees must show photo ID.

BAG POLICY

No bags other than the official NAMA sample bag can be used to collect samples.

SUITCASING POLICY

Any attendee who is observed to be soliciting business in the aisles, in another company's booth, or in any other public space will be asked to leave immediately. Additional penalties may be applied. Please report any violations you may observe to Show Management immediately.

RELEASE AND WAIVER
