## Food & Beverage Sampling/Corkage Approval Form

Levy Restaurant has exclusive food and beverage distribution rights within the Georgia World Congress Center Authority. Sponsoring organizations of expositions and trade shows, and/or their exhibitors may distribute sample food and/or **non-alcoholic beverage** products ONLY upon written authorization.

## **General Conditions:**

- Items dispensed are limited to products manufactured or processed by the exhibiting firm and are related to the purpose of the show.
- All approved food items brought into the building must comply with the Health Department and all applicable laws.
- If dispersing samples, exhibitors are required to have a hand sanitizing station in their booth (this can be as basic as sanitizing wipes or hand sanitizer and paper towels).
- If you require food preparation, heating or other kitchen services, arrangements
  must be made no later than 4 weeks in advance of the start of the event. Only
  Levy Restaurant catering staff may perform all preparation/cooking within the
  facility's production areas. Charges for these services will be based on the
  requirements.
- If preparation takes place within the exhibiting company's leased booth space, a
  description of size/equipment/processing procedure must be submitted in
  advance for approval.
- Food & Beverage may not be sold within Georgia World Congress Center.
- A sample size is defined as: Twelve (12) ounces for beverage samples and Six (6) ounces for food samples.
- If you wish to provide a sample item that is packaged, canned, or bottled (or anything that is larger than the 12 oz beverage or 6 oz food samples), a "buy out corkage" fee of \$500 per exhibiting company is required, payable to Levy Restaurants.
- Alcoholic beverage samples of any kind or size are prohibited.

The company named below acknowledges they have sole responsibility for the use, sale, servicing, or other disposition of such items in compliance with all applicable laws. Accordingly, the company agrees to indemnify and forever hold harmless Levy Restaurants and the Georgia World Congress Center Authority from all liabilities, damages, losses, costs, or expenses directly or indirectly from their use, sale, serving or other disposition of such items.

Standard fees for handling, delivery, ice, or other services required from Levy will be charged where applicable, including a 24% service fee and 8.9% sales tax.
